Colorado Mandatory Disclosure Statement

Education & Experience:

Rachelle Forsberg, ND, LAc was trained in Naturopathic and Traditional Chinese Medicine at Bastyr University in Seattle, Washington, a school with accreditation recognized by the US Department of Education. She received a Doctorate in Naturopathic Medicine in 2010 and a Master of Science in Acupuncture in 2012 after seven years of didactic and clinical training including over 4,000 hours of training in Naturopathic Medicine and over 2,000 hours of training in Acupuncture and Chinese Medicine. Dr. Forsberg practiced acupuncture in Washington state from 2012-2018, Dr. Forsberg has been practicing in Colorado since 2018. Dr. Forsberg's training includes adjunctive therapies such as moxibustion, tui na, acupressure, cupping, auriculotherapy, and dietary and lifestyle recommendations.

Dr. Forsberg holds active licenses as a Naturopathic doctor and an Acupuncturist in both Colorado and Washington state. None of these licenses have ever been suspended or revoked. Dr. Forsberg is recognized as a Diplomate of Oriental Medicine by the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM). This includes certification in Clean Needle Technique.

This clinic complies with the rules and regulations promulgated by the Colorado Department of Health, including the proper cleaning and the sanitation of acupuncture offices. Only single-use, disposable, factory-sterilized needles are utilized.

Informed Consent

I hereby request and consent to the performance of acupuncture and all other treatments within the scope of the above named licensed practitioner.

I have been informed that acupuncture is a safe method of treatment, but occasionally there may be some bruising or tingling near the needling sites that last a few days. There have been very rare instances reported of fainting, infection and scarring. There have been extremely rare instances reported of spontaneous miscarriage and pneumothorax. There may be some bruising after cupping.
